Enclosed you will find your Board approved budget for the fiscal year October 1, 2023 through September 30, 2024. The dues for this fiscal year will remain at \$526.00 per household, however, we'd like to point out that your dues have not increased since 2009, this will be 16 years that the dues have been at this same rate. Please be advised that we feel the dues may need to be increased within the couple of budget cycles in order to maintain the current level of services provided to Taunton Trace. Most of the line items on your budget are not discretionary and unfortunately, if costs continue to rise, what will be most affected is the line item earmarked for tree work, swale clean up and landscape improvements. If/when an increase is warranted, we will issue a voting instrument to obtain the required 2/3 of the members approval.

The Board of Directors has voted to approve accepting the dues in two installments, the first of which will be due no later than October 1, 2023 and the second installment due no later than April 1, 2024 <u>as indicated on the notice distributed on September 5.</u> Charges will appear on your portal on the due date. Please remember that a late payment will result in additional charges to your account and may include fees associated with collection efforts if necessary.

Please make payments through your AppFolio portal; <u>https://hwpm.appfolio.com/connect</u>. You may also continue to send in personal checks or use online banking. Please check your portal for any past due balance. Please be advised that any owner whose check is returned for non-sufficient funds will be charged a fee of \$60. This covers the bank fee charged to the association and administration costs. If this occurs twice, we will no longer accept personal checks and all payments will have to be made via certified check, cash or money order. Please do not send postdated checks, they will not be held, but will be deposited upon receipt.

ELECTION – Please see attached for information on how you can become a volunteer Board Member for the coming year. Candidate submissions must be received by October 9, 2023. Candidate information will be distributed to all homeowners who will have the opportunity to vote for the 2024 Board of Directors. Election ballots will be tallied at the annual meeting to be held on November 14, 2023 at 7:00 p.m. at the Keller Williams office (620 Stokes Road, Medford). We will also be answering any questions about the new budget, pending projects, etc.
